#### Notes to the financial statements

#### **General Information**

Midlands Polish Community is a company limited by guarantee without shared capital incorporated in the Republic of Ireland (CRO Register Number 711312). Registered office of the company is Drum Community Centre, Summerhill, Athlone, Co Roscommon. Each of the members is liable to contribute an amount not exceeding €1 towards the assets of the company in the event of liquidation. Financial statements have been presented in Euro (€) which is also the functional currency of the company.

#### Income

Income comprises of membership fees (waived in 2022), income from events (nil in 2022), grants, business sponsorship of events and projects, donations, collections for other charities organized by the company, fundraising to cover company's own annual expenses and running costs, loans (nil in 2022) and other income which would include payments received in error.

#### Cash and cash equivalents

Cash is represented by cash in hand, current and saving account with financial institution.

#### Fixed assets

The company purchased audio video equipment for its community TV subgroup which is represented by 'tangible assets' on the balance sheet.

#### **Expenditure**

Expenditure comprises of salary and pension costs (nil in 2022), projects organization and charitable activities costs, office supplies, equipment and internal training costs, fixed cost for internet, website, facilities cost (nil in 2022), insurance costs, professional fees for company solicitor, bank charges and fees, donations transferred to the other charities, loans payback (nil in 2022), and other expenditure which would include refund of money credited to the company's account in error.

#### <u>Liabilities</u>

Company has a company credit card in the financial institution – balance as of 31<sup>st</sup> December 2022 is shown in 'current liabilities' section under 'bank overdraft, credit card and loans' on the balance sheet.

#### <u>Directors' emoluments</u>

The company does not pay any renumeration to the Volunteer Board of Directors. Directors might be reimbursed for travel costs and for receipted expenses which in 2022 totalled €nil (in 2021 €nil).

#### <u>Directors' transactions, benefits and other arrangements</u>

There were no transactions, benefits and other arrangements or transactions in which the directors and/or officers of the company would have any material interest in 2022 and in 2021.
